Forensic Psychologist
to be located in Del Norte, Humboldt County, Lake or
Mendocino County

Redwood Coast Regional Center (RCRC) is one of 21 locally-based, non-profit corporations that contract with the State of California to develop and coordinate community resources and supports for people with developmental disabilities and their families, as outlined in the Lanterman Developmental Disabilities Services Act (Welfare and Institutions Code, Chapter 5, Articles 1 and 2, Sections 4620 through 4656). RCRC serves Californians who reside in Del Norte, Humboldt, Lake, and Mendocino Counties.

SCOPE OF SERVICES

Redwood Coast Regional Center is seeking proposals for a Forensic Psychologist to provide supervision and assessment services in Del Norte, Humboldt, Lake and Mendocino Counties. The Forensic Psychologist will work with the Regional Center and an authorized competency trainer. The field of Forensic Psychology focuses on psychology as it relates to the law and the legal system. The Forensic Psychologist will likely assist individuals in forensic settings with diverse backgrounds in a variety of co-morbidities. The successful applicant will be knowledgeable about competency training tools such as Slater Method and/or state approved training methods as well as be able to provide outcomes based on validated trainings to the court. The Forensic Psychologist will be the evaluator of the results of the competency trainer. However, the applicant must be familiar with competency-specific assessment tools such as Competency Assessment for Standing Trial-Mental Retardation (CAST-MR) and the Competency Assessment Instrument-Revised (CAI-R). The applicant must have applicable experience working with persons with Intellectual Disabilities, and have an understanding of the services and supports provided under the Regional Center System and the Lanterman Act for clients in the community. Applicants will be required to travel to various sites such as correctional and residential facilities.

Clients served have been court ordered to receive the training if after a professional assessment they were deemed either unable to participate in the judicial process because they don't understand the legal proceedings, or they are unable to assist legal counsel in their own defense.

The successful applicant will have a minimum of three year previous experience working with individuals with developmental disabilities and experience working with the specific populations this project is intended to serve. The applicant should have experience working within a clinical perspective of the vendoring Regional Center. Experience working in a protective setting (i.e.

jail, locked MHRC) is desirable, but not required. The applicant must be able to work independently; demonstrate familiarity with one or more standardized competency assessment tools. (i.e. CAST-MR, CAI-R); be familiar with mental health symptoms; and have the ability to establish essential contacts within the forensic community, including the Police Department, Sheriff's Department, Coroner's Office, and City Attorney's office. Experience in a mental health setting is not required but preferred.

This service may be a new development, or may be an adjunct service of an existing vendor. This service is based on court orders and does not have a constant flow of referrals. Services provided are likely to be intermittent and may range from 0-5 in any given year.

START-UP FUNDING

Up to a maximum of \$10,000 in start-up funds is available for the successful applicant. The funds will be awarded to the successful applicant depending on availability of funds and budget proposal. Start-up funding is provided by a separate contract process, and is to be used toward the development/expansion of this service, which may include but is not limited to:

- Office Equipment
- Staff Development (recruitment, training, up to three months wages)
- Consultation with Professionals in the Field of Developmental/Forensic services
- General Program Development Costs

TECHNICAL ASSISTANCE:

RCRC staff will provide the person(s) selected through the RFP process with technical assistance as needed in developing and completing the Service Design.

RFP REQUIREMENTS

All interested parties are required to submit a proposal to Redwood Coast Regional Center by **November 18, 2016**. All proposals received by the deadline will be reviewed, scored, and selected by RCRC. ALL proposals must include a cover page listing applicant's name, address, phone number, and name of person preparing proposal if other than applicant.

For Individual trainers the proposal packet must include the following 7 items:

1. A description of the applicant's relevant qualifications and expertise in reviewing competency training; serving people with developmental disabilities and forensic involvement; and familiarity with competency-specific assessment tools such as Competency Assessment for Standing Trial-Mental Retardation (CAST-MR) and the Competency Assessment Instrument-Revised (CAI-R). **20 points**
2. A statement regarding the applicant's philosophy regarding providing services to the identified population. **10 points**

3. A line item budget to show how funds would be used. *Reflect realistic costs of operating the service as required by this RFP (i.e. applicant's compensation, training costs, insurance and transportation costs, operating expenses, etc.).* **10 points**
4. A disclosure of all other businesses or projects that the applicant is involved with including those with other regional centers (identify the regional center). **5 points**
5. Provide last two years tax returns. **5 points**
6. A statement outlining your plan to serve diverse populations, including cultural and linguistic diversity. Provide examples of your commitment to address the needs of culturally diverse clients and any additional information your feel is relevant to your ability to provide services in an equal and diverse manner. W&I code 4648.11 (SB 208 Lara). **25 points**
7. Regional Centers have a zero tolerance policy for child and dependent adult/elder abuse pursuant to California Penal Code Section 11166.5 (children) and W&I Code Section 15630 (elder/dependent adult). Provide your agencies policy and procedures to ensure the health and safety of the clients served by your program. **25 points**

For Organizations the proposal packet must include the following 8 items:

1. A description of the applicant's relevant qualifications and expertise in reviewing competency training; serving people with developmental disabilities and forensic involvement; and familiarity with competency-specific assessment tools such as Competency Assessment for Standing Trial-Mental Retardation (CAST-MR) and the Competency Assessment Instrument-Revised (CAI-R). **20 points**
2. The specific staff qualifications required when hiring for this project. **5 points**
3. A statement regarding the applicant's philosophy regarding providing services to the identified population. **10 points**
4. A line item budget to show how funds would be used. *Reflect realistic costs of operating as required by this RFP (i.e. staff salaries, training costs, consultant fees, facility lease/rent, utilities, insurance and transportation costs, operating expense per in adjacent requirements, etc.).* **10 points**
5. A disclosure of all other businesses or projects that the applicant is involved with, including those with other regional centers (identify the regional center). **5 points**
6. Provide a current Balance Sheet or Pro-forma cash flow. **5 points**
7. A statement outlining your plan to serve diverse populations, including cultural and linguistic diversity. Provide examples of your commitment to address the needs of culturally diverse

clients and any additional information your feel is relevant to your ability to provide services in an equal and diverse manner. W&I code 4648.11 (SB 208 Lara). **25 points**

8. Regional Centers have a zero tolerance policy for child and dependent adult/elder abuse pursuant to California Penal Code Section 11166.5 (children) and W&I Code Section 15630 (elder/dependent adult). Provide your agencies policy and procedures to ensure the health and safety of the clients served by your program. **20 points**
