- 3. Review of June 24, 2016 Minutes:

- Topic #8, first bullet changed to read, "Once an individual has completed the pre-enrollment session and has been selected by DDS, they will then be required to participate in the orientation training". Bullets are to be removed.

- 4. **Statewide Self-Determination Committee Update** C. Lemas reported that, in early July, all local advisory committee chairpersons were sent draft training modules for each area of training. She also noted that, in general, she is happy with how much work has been done. It was emphasized that the same information needs to be received by everyone.
- 5. Del Norte County Representation on the Advisory Committee M. Block noted that a service provider from Del Norte County plans to make contact with a client who may be interested in participating in the meetings. The individual's service coordinator was also contacted. Pam J. noted that she made contact with several service providers who are checking with other individuals as well. ACTION: M. Block will follow up next week. C. Gillam-Sullivan and M. Block will check with the Families Advocating for Autism Now (FAAN) group about possible contacts in Del Norte County. This item will remain on the agenda until the participant is seated.
