1. Welcome, role call, and select timekeeper. P. Jensen agreed to be today's timekeeper.

4. Statewide Self-Determination Committee Update - The various topics and issues noted in the draft meeting minutes of the Oct. 27, 2016, Statewide Self-Determination Advisory Committee were discussed. Several corrections to the draft minutes were suggested. These minutes will be posted to the State Council on Developmental Disabilities' website when finalized.
5. Del Norte County Representation on the Advisory Committee – RCRC staff in the Del Norte County office continue to pursue recruitment of a representative for this Committee. **ACTION: In January 2017, M. Block will talk with K. Satern to identify further outreach efforts. D. Morley will send the initial informational flyer to M. Block. M. Block will work with support staff to send the informational flyer and the 2017 meeting schedule to Del Norte County clients age 3 and older. The information will also be provided to service coordinators so they can have it for families at their regular meetings. The Spanish language version of the flyer will also be available.**
6. State Council Meeting Report – D. Morley announced that the dates for the Statewide advisory committee have not yet been set. State Council's meeting calendar is posted on their website. Citizens can attend those meetings by calling in. All were encouraged to discuss Information about the Self-Determination Program in their communities.
7. Statewide SDP Workgroup Update  
S. Keys provided a brief overview of the discussion that took place with regard to answering the questions in order for the Program to move forward.
8. SDP Training Workgroup Report – S. Keys reported that a few photos have been offered for use on the Local Advisory Committee's brochure. Consent releases are needed and a "call for photos" might be made in order to have a good selection of photos to choose from. The group is interested in conducting a meeting early in 2017 to include persons who have been involved

with SDP in the past. **ACTIONS: D. Morley and S. Keys will create a photo consent form. S. Keys will invite current SDP participants to an informal, informational event toward the second half of January 2017.**
